Dersin İçeriği:	<p>The course explores the history, rationale, and evolution of the European Union's European Neighbourhood Policy. It assesses its relevance, its mutations, and the debates surrounding its future. In order to do so, the course will also examine the debate on the evolution of regionalism and its pertinence to the European context, the nexus between security and democracy in the neighbourhoods, and the differences and similarities between the Union's Eastern and Southern Neighbourhoods. It will also explore spin off policies such as the Eastern Partnership, the Black Sea Synergy, the Euro Mediterranean Partnership (which precedes the ENP), and the Union for the Mediterranean and assess their effectiveness.</p> <p>The aforementioned are some of the issues we will discuss in this seminar course. Students are expected to be actively involved in the discussions and be prepared by writing outlines of the readings for the particular class and presenting them; write two in-class book reviews; and to produce a major research paper (6000-7000 words) and present their original work as part of the course.</p>
