In particular, it assesses the process of regional cooperation from both a historical and a theoretical approach with a particular focus how this process has developed in the Black Sea Region in the post-Cold War era, when it acquired greater clarity and depth. The course also looks at issues relevant to economic cooperation and development, with a particular focus on the role of the Organization of the Black Sea Economic Cooperation. The course also focuses on a number of regional security concerns such as "frozen" and "protracted" conflicts in the region and energy security. In this context, the role of powerful regional and extraregional stakeholders such as Russia, Turkey and the United states is evaluated. Finally, the role of the European Union as a rising power in the Black Sea Region is explored in depth. There is an assessment of its European Neighborhood Policy as well more recent initiatives such as the Black Sea Synergy and the Eastern Partnership and how these impact on the Black Sea Region in conjunction with the increasing role of the European Union in its attempt to resolve the various "protracted" conflicts in the region as well as the parallel development of a cohesive energy strategy.
